

Arcare Fee Schedule

At Arcare, our goal is to provide families with professional, personalized services that ensure their loved one with a disability will receive caring support throughout their lives. Because Arcare is a certified 501(c)(3) non-profit organization, our expenses are met by fees. Some fees are mandated at the state or federal government level, while others simply ensure we can continue providing our services at a cost reasonable to those we serve.

Life Care Plan Program

Initial Planning Services – \$450

This includes 10 hours of initial planning services provided by Arcare. Additional hours will be assessed at the current hourly rate. A discount of 50% is offered for families enrolling an additional child.

Annual Life Care Plan Renewal Fee – \$65/year

Arcare offers families the opportunity to review the current Life Care Plan in place for their loved one with a disability to ensure it reflects current preferences and priorities. Additional updates are available at the current hourly rate upon a given family's request.

Service Fee – \$60/hour (plus mileage expense)

Services are provided by Arcare at the current hourly rate noted above. These include Life Care Plan Services and Guardianship Services. Families are encouraged to set aside funds through special needs estate planning to pay service fees. Please consult with Arcare staff for more information on the Arcare Pooled Trust Program.

Representative Payee Program

Payee Program Fee

As an organizational representative payee, Arcare is required to charge the fee amount regulated by the Social Security Administration. Additional fees may apply if Arcare manages income other than or in addition to SSI and SSDI.

Trust Services Program

Trust Enrollment Fee (based on initial deposit)

If deposits exceed current category maximum during the first 3 months of enrollment, an additional \$250 fee will be charged against the account.

Initial Deposit Under \$5,000 – \$250

Initial Deposit \$5,000 to \$9,999.99 – \$500

Initial Deposit \$10,000 to \$14,999.99 – \$750

Initial Deposit \$15,000 to \$19,999.99 – \$1,000

Initial Deposit \$20,000 to \$49,999.99 – \$1,250

Initial Deposit \$50,000 and over – \$1,500

Trust Administration Fees

These fees are assessed throughout the life of the Trust:

- 1.5% of the account balance (includes postage, fiduciary management and benefit maintenance)
Note: The annual fee will be charged on a monthly prorated amount based on your account balance at the end of each month.
- \$15 for each transaction in excess of 24 per year
- \$5 for each transaction made by Arcare credit card
- Up to \$100 per year for tax return preparation on your trust account

In addition to Trust Administration Fees, Investment Custodial Fees (currently 0.70% annually) are based on the month-end market value and will be assessed in arrears on a monthly basis as of the prior month-end market value.

Trust Care Management

This includes activities above and beyond routine Trustee Services (e.g., shopping, home care assistance, etc.).

Pooled Trust Care Management – \$45/hour

Private Trust Care Management – \$75/hour

Trust records necessary in the administration of Arcare Trust I and II will be maintained by Arcare and will be open and available to designated persons upon request.

Conservatorship Services – \$85/hour

Financial management services related to conservatorship are provided at the current hourly rate noted above.
